




# Number of Youth Served Decreased, Despite No Reduction in Statewide Capacity




# While Statewide Capacity Remains Unchanged, Rural Areas Lost Services






# THP-Plus Rate Remains Unchanged on Average




### Distribution of Rates





### Percentage of 21 to 24 Year-Olds




### Percentage of Women who were Custodial Parents




# More Youth Are Entering From Homelessness and Experiencing Homelessness

### Percentage of Youth Entering THP-Plus who have Experienced Homelessness




# THP-Plus Participants Made Gains in Earning and Employment

## Increase in monthly earned income, from entry to exit (\$)




## Increase in rate of employment, from entry to exit




## Almost Half Increased Their Educational Status, But Degree Attainment Remains Very Low

# Health Care Access Continues to Be an Issue, Despite ACA Implementation






## THP+FC Experienced Significant Growth

### Number of NMDs Placed in THP+FC




# By End of Fiscal Year, THP+FC is Located in Most Counties

### Number of Counties with THP+FC Housing




### *Number of Licensed THP+FC Providers*




# Parenting and Probation Youth Are Utilizing THP+FC


### Number of Parenting Youth in THP+FC

## Implications

In FY 13-14, 2011 Realignment did not result in a reduction to the number of youth served by THP-Plus or the rates paid.

THP-Plus will be an important resource in 2015, as youth begin to "age out" of extended foster care.

THP-Plus requires new approaches to engage youth in postsecondary education.

Additional outreach is required to enroll THP-Plus participants in Medi-Cal to age 26.

## Implications

Additional consideration must be given to ensure THP-Plus and THP+FC are meeting the needs of parenting youth.

Despite significant growth, THP+FC requires additional expansion.

While providing valuable supportive services, THP+FC is not adequate for very high needs youth, such as those with serious mental illness.

Outcome data is required to ensure program quality.

## Policy Update

THP+FC will receive a CNI increase for FY 14-15, retroactive to July 1, 2014.

### On the Governor's Desk:

- **Senate Bill 1252**, which would provide counties with the option to allow youth in THP-Plus who are enrolled in school to participate for 36 months.
- **Senate Bill 1023**, which would create a new program for current and former foster youth within the existing EOPS program on community college campuses.
- Assembly Bill 2668, which would provide parenting youth in a SILP an extra \$200 if they enter into a Responsible Parenting Plan.
